

Hutchison Ports Australia Portal Terms of Use

1. Terms of use

These terms of use govern your use of the Hutchison Ports Australia Portal currently located at <https://www.hpaportal.com.au/>. By using our portal, you agree to be bound by these terms of use.

In these terms of use, a reference to “we” and “us” means Hutchison Ports Australia Pty Ltd (HPA). A reference to “you” or “your” in these terms of use is a reference to any person accessing, reviewing or using our portal.

We reserve the right to not provide you with access to our portal at any time for reasons including but not limited to a breach of these terms of use, a breach of the HPA Terminal Carrier Access Terms and Conditions, or if you are in default in respect of any payment due and payable to HPA (including non-payment of the Portal Fee outlined in clause 5) irrespective of any relevant set-off or counter-claim that you may have.
