Truck Appointment System (TAS) Annual Subscription	\$220	Renewal payable annually in July
Truck Appointment System (TAS) Re-registration	\$220	Payment in the event of re-registration after de-registration (due to breach of HPA Terms and Conditions)
SMS	\$0.5	Per each SMS sent
Public Appointments	\$12	Per Appointment/ Container
Private Appointments	\$23	Per Appointment/ Container
Stack Run In Fees	\$10	Per manual move, by application to the terminal
Manual Truck Manifest Processing	\$100	Per container - For manual correction of truck manifest by terminal staff upon truck arrival. The option to manually correct the manifest or Non Service will be at the Terminal's discretion.
Container Re-handling	\$100	Per Container re-handled. (Physical re-handling of containers due to, but not limited to the following: truck over-weight, truck over-height, damaged container, container re-positioning, or changing door direction)
Sideloader Fee	\$50	Per Truck visit for one or more moves
Infrastructure Levy*	\$10.45	All full containers received or delivered via SICTL will be subject to the Infrastructure Levy.

Container Storage Charges Notes:

1. Each Storage Charge will consist of the applicable charges outlined in sections 1, 2, and 3 in the above table.
2. Per TEU Charges will be calculated as follows:
 - a. A 20' will be charged as per the rates shown in the table.
 - b. A 40' or 45' will be charged 2 times the rates shown in the table.
3. FSP – Free Storage Period. Storage charges apply from 'Import Storage Start' date for the vessel voyage as published in the hpportal.
4. GST - All tariff rates are exclusive of GST which needs to be added to the total charge.
